Entry Requirements

Applications close on 31 January 2011.

This scholarship is open to all eligible members of the Australian Women Pilots' Association and may be used for fixed wing, rotary wing, gliding or balloon flight.

The intended use of the scholarship could include initial twin endorsement, tail wheel endorsement, constant speed endorsement, retractable endorsement, Biennial Flight Review, PPL training, CPL training, Private Instrument rating (PIFR), float plane endorsement, GPS endorsement, cross country gliding rating, aircraft type endorsement. It is intended that the scholarship be used for the attainment of one qualification only.

This list is not exhaustive and is for guidance only.

Note: This scholarship is not intended to be used to obtain a Command Instrument Rating (CIR), Flight Instructor Rating (FIR) or Night Visual Flight Rules rating (NVFR).

All Applicants

1. Membership of AWPA - twelve months minimum.
2. Hold a current Australian Medical (as applicable).
3. Have successfully completed a GFPT or higher flight test **or** equivalent for gliding or ballooning.
4. Hold the appropriate license or rating to undertake the proposed flight training.
5. For PPL, CPL or PIFR, passes in the appropriate theory examinations must be completed by the nominated application closing date of 31 January 2011 (evidence to be provided).

Entry Requirements

6. Attach the following documents to the application form:
Two (2) copies (original plus one) of -
- The application form including essay
 - A copy of license or log book entry indicating highest license or rating held.
 - A copy of the result slips for theory examinations (as applicable)
 - A cost estimate from the proposed flying school or organization providing the training

All recipients of scholarships must have completed their training and have their license/log book endorsed within twelve months of receiving the award. This can be reviewed in extenuating circumstances upon application.

The scholarship monies will be paid to the flying school/organisation of the recipient's choice on a dollar for dollar basis up to \$2000.

Proof of payment (statements and receipts) must be supplied.
